Under current law, individuals are able to seal a record of one misdemeanor and one felony — with restrictions — but some individuals with multiple low-level misdemeanors are not eligible and the ability to seal and expunge records in some cases should be broadened, Albany County District Attorney David Soares said.

o Expungement: Erases arrests and court supervisions from your criminal record so it is like they never happened. Qualified Probations (see definition on Page 15) are only sealed by the State Police, but are erased by the arresting agency.

HOW TO EXPUNGE AND/OR SEAL A CRIMINAL RECORD

An eviction, also known in some states as an unlawful detainer, can stay on your record for life, but all states have a process in place to expunge an eviction from your record. Expungement is an order issued by a judge sealing your court record from public view. If expunged, records of your case will not appear in searches of public records.

5 Tips to Expunge an Eviction from Your Public Record

Except for some marijuana crimes, New York has no laws to erase or “expunge” criminal records. New York uses a process called sealing for some cases. Sealing means that the record still exists, but all related fingerprint and palmprint cards, booking photos, and DNA samples may be returned to you or destroyed (except digital fingerprints ...
